Landmark College welcomes the formation of the Friends of the College Advisory Council (FCAC), a group of parents of current and recent Landmark College students. The group was formed as a way of giving something back to the institution that helped their children so profoundly.

Initial membership includes 11 families from nine states across the country, giving the group a truly national footprint. Members will serve two-year terms and report to Dr. Katz through the group's chairperson, who will serve as an ex-officio member of the Board of Trustees.

The primary mission is for group members to act as advocates for the College in their home communities and provide feedback to Landmark. The group also will help with various institutional initiatives when needed.

Most group members already have completed training and have begun delivering the Landmark message to high school guidance and special education professionals. Members have also served as consultants in Landmark's efforts to improve its Web site, and a few volunteered for video interviews to be used in Landmark's marketing efforts.

At the group's kickoff meeting earlier this year, President Katz and the Board welcomed members and shared the College's strategic plan. At the next meeting, the College's leadership will share how Landmark is organizing around the plan and its "early returns" and seek the group's input and guidance. The group is also poised to support the College's new development initiatives.
